Issues Douglas County/DOTCOMM was facing that required them to seek a contract management solution

Douglas County and the Douglas Omaha Technology Commission (DOTCOMM) had a single person in the purchasing department keying contracts into a “homemade” Microsoft Access Database. Some contracts were lost in this process, while others could not be completed because different departments could not review, edit or enter new contract information. This homemade solution made reviewing contracts extremely time consuming, and did not allow for efficient and timely renewals for expiring contracts. Due to these limitations, Douglas County/DOTCOMM needed a more robust and centralized system.

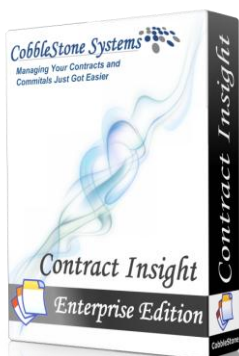
